The ride is not limited to a number of horses. Please be sure to call in advance if hand-carrying entries.
3) Owners AND Riders must be AHA competition level members. You may join on our website at www.ArabianHorses.org
4) A \$25 substitution fee will be charged per horse per rider substitution.
5) Entry fee will be refunded (less \$50 processing fee) for illness or injury (horse or rider), provided a letter from entrant and vet/doctor letter is received by AHA before the ride Vet Check-In.
6) If also entering the AERC Open Ride, please also complete an AERC Entry Form. AERC Entry Fees are included in the AHA Entry Fees.

AHA TERMS & CONDITIONS FOR ENTRY & RELEASE, WAIVER AND IDEMNIFICATION AGREEMENT

Every person or entity executing this entry form agrees and represents that: (1) the person and entity executing this entry form and the horse(s) to be exhibited by the entrant are subject to and bound by Rules of the Arabian Horse Association ("AHA") and the rules of the entity or entities that are responsible for organizing and conducting the event (the "Ride"); (2) that every horse, rider, driver and handler is eligible as entered; (3) that the entrant and any of his representatives agree to accept as final the decision of any applicable hearing committee authorized by AHA on any question arising under AHA and the Ride, as applicable; (4) that permission to enter a horse and the rental of any storage, stall, or tack space, if granted, shall not create a bailment between AHA, the Ride, the Regions or the club, the facilities leased by "the Ride" and state wherein held, and the entrant or others and, at all times, horse and any other property belonging to or accompanying the entrant shall be under the care, custody, control and supervision of the entrant; (5) the entrant agrees to fully indemnify and hold harmless AHA, the Regions, the Ride, the facilities leased by "the Ride" and the state wherein held, and their agents, employees, contractors, officials, officers, directors, successors and assigns from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations, including, but not limited to, any and all attorneys' fees, of whatsoever kind and nature which may be incurred by or asserted against any of them as a result of any act, failure to act, or neglect by the entrant, his agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees, or by any animal owned by, accompanying or exhibited by the entrant; (6) the parties executing this entry form, for themselves, their heirs, executors, administrators, successors and assigns release and forever discharge AHA, the Ride, the Regions, the facilities leased by the Ride and the state wherein held, and the Club, their officials, officers, directors, agents, employees, contractors, successors and assigns from any and all rights and claims for any damage, loss or injury to themselves, other persons, horses or other property belonging to them to the fullest extent permitted by law arising out of or relating in any way to the Ride and participation in the Ride including, but not limited to, damages resulting from or due in whole or in part to any acts, failure to act, negligence or neglect of other entrants, AHA, the Ride, the Region, the facilities leased by "the Ride" and state wherein held, and the club, or their agents, employees, officials, officers, directors, contractors or invitees, as well as for theft vandalism, fire, other casualty damage, or damage arising out of any defects in the premises; (7) the entrant acknowledges that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event and grants AHA the right to make use of any photographs, films or videotapes taken of the below entered horse(s) and riders/drivers/handlers while on the grounds or in transit between the stabling facilities and the event site, in any way they see fit in the promotion of the Ride or AHA. No such advertising or promotional rights shall include the right to use a participant's name or likeness in a manner which implies endorsement of any company, product or product category, or service; (8) if AHA, in its sole discretion, deems that circumstances have arisen which require cancellation of the Ride in its entirety, or cancellation of any particular event during the Ride, then all applicable fees shall be refunded in full, but AHA shall not be liable or otherwise responsible to the parties executing this form or any of their representatives for any costs, damages or expenses resulting directly or indirectly from such cancellation.

I understand competitive riding involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities. I recognize ride management can not eliminate or control all potential hazards to me or my horse or act to guarantee our safety. I agree to abide by the rules of the ride and AHA.

WARNING: Under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

WARNING: Under Oklahoma law, an equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

I know and understand competitive trail riding is an inherently dangerous sporting event and agree to assume the complete risk of injury or damage which I or my horse might sustain in competing in this ride. As a result, I agree to indemnify and hold harmless the ride management, ride landowners, veterinarians, ride members, and agents from and against all loss or damage, including property loss, suffered during or in connection with the loss resulted directly or indirectly from negligent acts or omissions of the ride management, ride landowners, ride veterinarians, AHA, their directors, officers, committee members or agents.
