20 clinic at least once every three years; Therefore, Be It

22 Resolved,                      That the following exception be added to USEF Article GR1022.2

24                      EXCEPTION: Regional and National Level 1 Judges shall attend a clinic at least once every five years. At  
25 the request of Education Evaluation Commission (EEC) or the AHA Judges and Stewards Commissioner’s  
26 office a judge may be required to attend a clinic out of their regular clinic rotation.
