- 20 Whereas, In the opinion of the proponent horses not re-qualifying in their respective Regional class has actually
- 21 accelerated the decline in the number of horses attending the Regional classes; and
- 22
- 23 Whereas, In the opinion of the proponent we are being forced to haul previously qualified horses to re-qualify and
- 24 struggling to find classes for our newer horses, and
- 25
- 26 Whereas, In the opinion of the proponent more horses will compete in our Regional classes and make exhibitors
- 27 available to show other horses in Class A shows.

- 29 Whereas, When the point qualifying system was put into place, the Points Monitoring Committee acknowledged that
- 30 it was a work in progress and that it would take “tweaking” along the way; Therefore, Be It

- 32 Resolved, That all horses awarded a Top Five in a Regional Championship class, be automatically qualified for the
- 33 same class the following year.
