- 16 Whereas, The Arabian Horse Association in its Articles of Incorporation, has stated in Chapter 1, Article II.3 that one
17 of its purposes is to “aid and encourage the breeding, exhibiting and perpetuation of the purebred Arabian
18 Horse as well as Half-Arabian and Anglo-Arabian Horses”, and
19
- 20 Whereas, It is also stated in Chapter 2, Article II.6 that an additional purpose is to “promote, encourage and stimulate
21 popular interest in the outstanding qualities of the Arabian Horse”, and

- 23 Whereas, There is a growing interest in the reestablishing of the Arabian, Half-Arabian and Anglo-Arabian in the
24 discipline of cutting classes, and

- 26 Whereas, Judges used for Cutting classes must be educated and licensed by the National Cutting Horse Association,
27 and

- 29 Whereas, To encourage additional growth in this discipline; Therefore, Be It

- 31 Resolved, That those exhibitors and horses participating in only Cutting Horse classes at any AHA recognized show
32 are exempt from paying the educational fees in Resolution 9-90 collected at all AHA Recognized shows,
33 including Regional and National Championship Shows.
