When I was born, my family had a riding stables which was in the business of offering public trail rides and riding lessons as well as boarded over 40 horses. I worked the stables from a very young age (it is actually how I became a lawyer - but that is a story for another day). Although most of our horses were unregistered grade horses and quarter horses, we had two half Arabian geldings. They were by far my favorite horses. They were so "alive," beautiful, intelligent, brave, proud and versatile As a very determined teenager, I successfully begged my father to buy a purebred Arabian that I could show at the Class A level. The rest is history.

In 1983, we bought our third Arabian that changed our lives. On a very ambitious grey gelding, I won several National and Regional Championships including U.S. National Champion Native Costume AAOTR class, the first year it was offered.

There never was a time that I did not own an Arabian. In fact, I competed through college and law school and even in the early part of my legal career while working for a National law firm. The law firm hired me knowing that they had to allow me time to "show my Arabians".

In 1989, I met (and later married) a prominent Arabian Horse Trainer. From that point until 2000, I was fortunate to be part of a first rate training center that produced many National Champions. During these years, I personally won several National Championships, Top Tens and

Regional Championships in a variety of divisions on a group of wonderful horses. I also was very involved with our local Arabian Clubs, and served for many years on the Buckeye Show Committee.

After my divorce, until the present, I have owned and shown horses with a variety of trainers (always trying to match the horse with the trainer). Importantly, because of my experiences as a "service provider" through my family's stable and my husband's training center and also being a "consumer of services" as a client and amateur owner, I have gained perspectives that appreciate the needs and challenges of both groups.

There was a time (2005-2012), when as a single mother supporting her athlete child as well as a full-time attorney, that it became too challenging for me to continue to be involved as much as I desired. However, during these years I continued to own Arabians.

In 2013, I was able to become re-engaged and have been able to continue to increase my participation each year. In the past decade, I have shown as an amateur in a wide range of divisions at the Regional and National levels. In addition, I regularly support our local Class A shows, attending the OHAHA Spring Show and the Buckeye each year. My horses also attend local unrated shows introducing others to our wonderful breed. I have attended the last two "in person" Conventions in 2022 and 2024 (as a delegate). I believe that my involuntarily hiatus from active industry involvement, followed by re-engagement, has given me valuable insight into the reasons behind our members stepping away and the motivations that inspire them to return.

This spring, I worked and helped plan the AHA Booth at the Ohio Equine Affaire. During the four day event, I spoke with hundreds of attendees who love Arabian horses. Our conversations gave me additional insight on reasons that we have lost members, but more importantly, it gave me a true sense of the mass quantity of horse enthusiasts who absolutely love Arabian horses. I am Co-Chairing the Region 14 Equine Affaire Committee for 2026.

I have also been very active this year with the terrific Local Level Committee that has worked tirelessly to develop strategies and provide resources and tools to make it easy for anyone to introduce new people to the Arabian horse. These initiatives and resources include the promotional outreach grants (to be used to introduce the Arabian horse to the public), Discovery Farms, website updating, and lesson and academy programs.

I currently own eight Arabians or Half Arabians. I am actively involved with the Arabian Breeders Sweepstakes. I own a Nominated Stallion as well as the remaining frozen semen of the deceased Breeders Sweepstakes nominated stallion, Promotion (Bask x Prowizja). My purchase of Promotion's remaining semen reflects my dedication to the Arabian breed and the importance of responsible generational breeding. My sole goal is to reintroduce his genetics into the Arabian gene pool before it is lost. My other horses are Arabian Breeders Sweepstakes Original Entries.

As one of the Purebred Arabian Trust's appointees to the AHA Board, I have been given the opportunity to understand the current status of the industry and its historical trajectory. This knowledge has served a single purpose of heightening my desire to be engaged and assist in the

turnaround of our Industry by working closely with everyone to identify creative solutions to rebuild our amazing Industry by promoting, preserving and growing the Arabian breed.

Also worth noting is my passion for supporting our youth. I have loaned my horses to several youth riders over the years who were able to win multiple National and Regional titles with such horses. Currently, three of my horses are leased out to lesson programs and to a 4H Rider.

In summary, I am very committed to assist in any way needed to ensure the viability, sustainability and success of the Arabian breed that I so dearly love.
