The reservation is not confirmed until the Application & Contract is received by AHA for the dates requested. If a reservation is cancelled within 30 days of an event, a \$100 hold deposit will be charged to the requestor. Shipping costs of the Booth and promotional materials to and from AHA are the responsibility of the requestor. The requestor is responsible for the care of the Booth and will be charged for any damage or repairs required upon return up to \$4,000. Booth must remain in an indoor, climate controlled building.

This Application & Contract must be completed in full and signed by an authorized representative of the business named above. AHA/AHYA Booth reservations are NOT confirmed until a contract, complete with credit card information, has been received by the Arabian Horse Association. Applications are granted on a first-come, first-serve basis, and must be submitted in full within 30 days of the event date. The Arabian Horse Association reserves the right to approve or deny any requests without question or consent.
