  - all markings must be drawn on the back of the affidavit form.
- If the horse has been sold, please complete the transfer section and include the transfer fee.

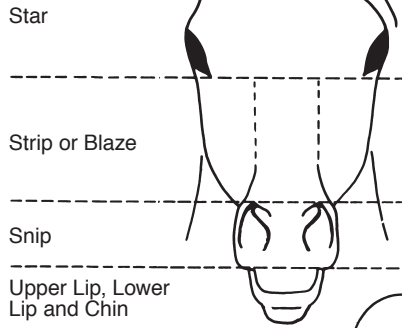

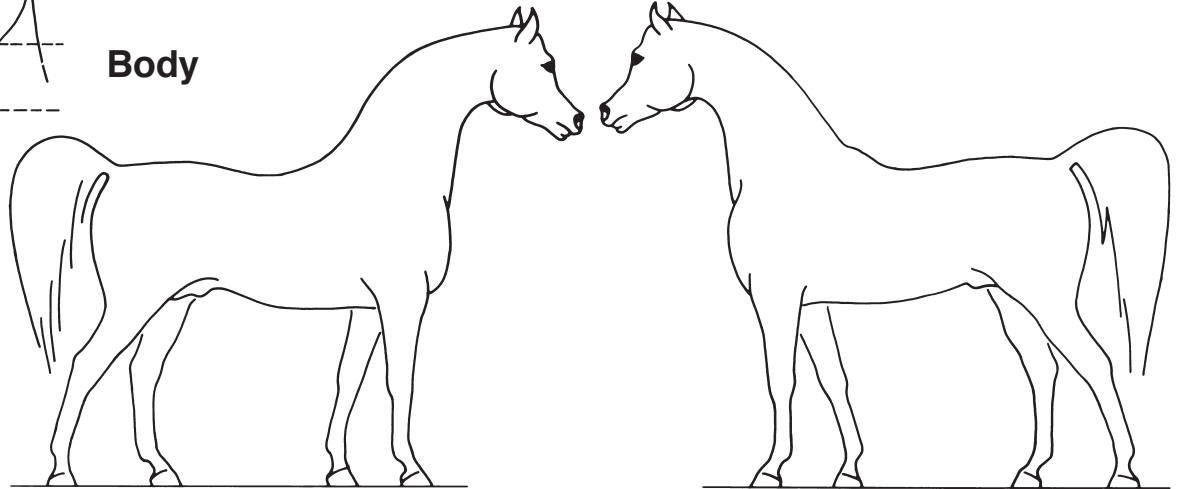

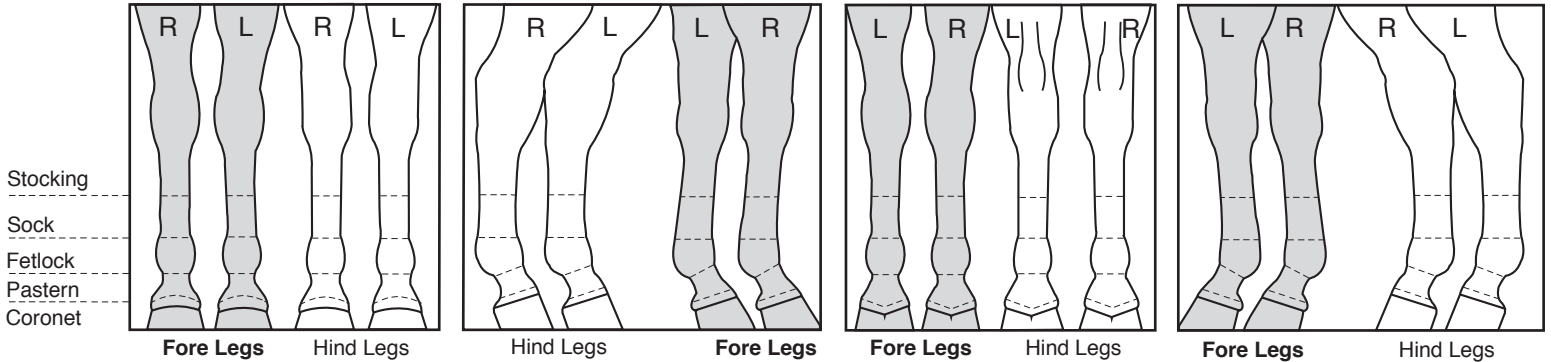
