## PROGRAM INFORMATION

Please refer to the Chapter 18 of the current AHA Handbook for specific rules, regulations regarding the Arabian Breeders Sweepstakes Program.

The Original Entry (already born) is an opportunity for you to enroll your horse in the Sweepstakes Program and be eligible to earn prize money.

An Original Entry is open to any living horse registered with AHA or the Canadian Registries (CAHR or CPAR). **This entry requires that the horse be out of a Nominated Dam or by a Nominated Sire.** They are eligible to win Allocated Prize money in Sweepstakes designated classes for the horse's life with the exception of the Regional and National Yearling Sweepstakes halter classes.

A horse enrolled as an Original Entry can show in Regional and National Sweepstakes designated classes. This includes the ABS Ranch Horse Rail Pleasure AAOTR and ABS Ranch Horse Riding AAOTR at Mid-Summer Nationals; ABS Dressage Prospect Incentive, ABS ATOR Sport Horse Under Saddle and ABS Green Working Hunter Derby at Sport Horse Nationals; the ABS Performance Halter and ABS AAOTR Jackpot Classes at U.S. Nationals. A horse that is co-owned by the two distinct non-family members cannot be shown in AAO Jackpot classes at any AHA National Championship Show. The Regional and National Yearling Sweepstakes classes are restricted to Breeding Entries only. Only horses enrolled in-utero as Breeding Entries are eligible for Breeder/Nominator payback and a discount if entering the horse as a Nominated Sire or Nominated Dam.

If enrolling additional foals/horses in the Sweepstakes Program (Breeding Entry/Nominated Sire/Nominated Dam/Original Entry) on a Deferred Billing Agreement, a separate Arabian Breeders Sweepstakes Deferred Billing Agreement must be completed.

### **Prize Money Payout**

Prize money checks shall be mailed no later than 60 days of receipt of completed results. All prize money will be issued in U.S. funds.

Checks will be issued to the recorded owner of the horse at the time of the show. If a horse is sold and the transfer date is during the dates of the show, the prize money will be issued to the new recorded owner of the horse.

Prize money payouts are federally reportable as income. Therefore, a Tax ID must be associated with each account that receives payout. A Tax ID (TIN or Social Security Number) reported on form W-9 is required for the release of any such payment regardless of the amount. If a W-9 form for said account is not on file, the payout will be placed on hold until the form is received. If this information is not provided within 120 days after notification, all Sweepstakes Prize Money will be forfeited.

Foreign residents winning prize money at an event held in the United States will be subject to income tax of 30% per Internal Revenue Service regulations. This amount will be withheld from total winnings.

If a prize money check is issued and not presented for payment by December 31 of the year following the year in which the prize money was won, the prize money shall be forfeited
