**1 Point Penalties:**

- Too slow / per gait
- Over-bridled
- Out of frame
- Break of gait at walk or trot for two (2) strides or less

**3 Point Penalties:**

- Break of gait at walk or trot for more than two (2) strides
- Break of gait at lope
- Wrong Lead or out of lead
- Draped reins

**5 Point Penalties:**

- Blatant disobedience (kick, bite, buck, rear, etc.)

Posting at the extended trot and touching or holding the saddle horn is acceptable

**10 Point Penalty:**

- Eliminates or adds maneuver
- Incomplete maneuver
- Off Pattern

**Zero Score: (0)**

- Willful Abuse
- Major disobedience or schooling
- Illegal use or improper use of reins

**Disqualification (DQ):**

- Fresh blood in the mouth, nose, chin, shoulder, barrel, and or hip area. SEE USEF AR105.6

**NO specific penalties will be incurred for:**

Nicks/hits on logs/poles or over/under spins, but deductions may be made in maneuver score

**Major penalties (no score, zero, or penalties of 5 or higher) must be reviewed.**
